Number of bids received by category:

General Construction – 2 Mechanical Construction – 2 Electrical Construction – 5 Plumbing Construction – 2

The low bids are as follows:

General Construction – L. J. Paolella Construction, Inc. - \$250,000.00 Mechanical Construction – Five Star, Inc. - \$107,500.00 Electrical Construction – CSME, Inc. - \$32,202.00 Plumbing Construction – John J. BEE, Inc. - \$84,900.00

Total cost of the project based on the above is \$474,602.00 contingent upon a 30 day comment period for additional funds requested from Delaware County. The County has increased funding to \$347,000.00 leaving Upland Borough to pay \$127,602.00. Mr. Archdeacon recommends awarding the bids noted above.
