A-1 Fire Marshal/Public Safety Officer's Report – August 2023

Mr. Smith read the Fire Marshal/Public Safety Officer's Report for August 2023 into the record.

Mr. Smith had no health department report, but informed Council that the Dollar Store (Family Dollar) was closed indefinitely by Delaware County's Board of Health for rodent infestation. Mr. Smith wants to meet with the Board of Health (possibly Thursday) to understand why they are not notifying the Borough of issues. He discovers issues through the Borough's Police Department.

Mr. Smith also informed Council that he worked with PennDot on the Upland Avenue project between Upland Avenue and Medical Center Boulevard. He confirmed that day with Mike Burns, Supervisor of District 6, that the rippling of the road from Upland Diner to the hospital will be milled and resurfaced within the next two weeks.

Mr. Smith stated that he submitted a letter to all Council members for qualifications needed for a burn pit. He performed the inspection at 3415 JFK Drive that day and met with the homeowner. The homeowner did meet all the qualifications and restrictions required for a controlled burn permit. He requested that Council approve the permit.
