Mr. Smith stated that he received a request for a propane controlled fire pit for 105 Griffith Street on October 3, 2023. He spoke with the tenant, Ms. Megan Bush about the rules and regulations. She has met all the qualifications and he is seeking Council's approval.

Mr. Smith then addressed Mr. Archdeacon concerning the status of the hydrology study discussed earlier this year. He was questioning when the Borough will receive the bill in order to submit for payment from the County. Mr. Archdeacon stated that the bill is ready and will be sent to the Borough. He also added that the study is still being developed.

Ms. Crawford asked Mr. Smith about the potholes on Upland Avenue. Mr. Smith advised that he had been speaking with Mike Burns of PennDot about this issue. Mr. Burns went to the sight and noticed that the potholes were not filled in even though the workers were told twice to do so.

He had the job supervisor handle the situation immediately. Mr. Smith said that the areas were starting to cave in again due to the material used to fill in the potholes. He feels that the Borough needs a definite answer concerning who is responsible for the pipe under Upland Avenue. Once known, he can move forward on looking into how to handle the issue.
