Ms. Crawford reported that the Easter egg hunt and the breakfast with the Easter Bunny held on April 16, 2022 were well attended. The breakfast was the first sit down event in MacQueen Hall in 2 years.

The movie in the park that was to be held on May 15, 2022 was postponed due to weather. Rather than reschedule this as a stand-alone event, Ms. Crawford suggested that Chief Irey consider adding this to his National Night Out event on August 2, 2022. Chief Irey approved the idea. Ms. Crawford added that she will keep the second movie in the park scheduled for August 20, 2022.

The July 4th events will be held at Bristol Lord Field from 11:00 a.m. to 1:00 p.m. All is free for current Borough residents. The festivities will include: sprinklers for the kids, free food while supplies last (pretzels, water ice, chips, candy, beverages and hot dogs donated by the Upland Athletic Club), a DJ, balloons, some games and clowns will be doing balloon sculptures and face painting.

Finally, Chief Irey spoke at the Delaware County Italian-American Heritage Festival at Rose Tree Park on June 5, 2022. Officer Canzanese, Raymond, Lieutenant Curran and Halo attended also. There were about 10,000 people at the festival.

Ms. Crawford informed Council that the Parking Committee met on June 8, 2022. They discussed the possibility of adding additional parking lots in the Borough. He went through the rules and regulations with them, examined the area and the fire pit set up. The owners obtained the permit on June 6, 2022.

After meeting all qualifications, Mr. Smith recommends that Council approve the permit.
