A-1 CDBG 2021 MacQueen Hall Addition – Approve Application for Payment #4 to CMSE, Inc. in the Amount of \$14,813.00 for Payment by Delaware County OHCD

Mr. Archdeacon reported that the CDBG 2021 MacQueen Hall Addition work is approximately 60% complete. Application for payment #4 for Contract 3 Electrical Construction was submitted by CMSE Inc. in the amount of \$14,813.00 and is recommended for payment by Delaware County OHCD.

Ms. Crawford made a motion to approve application for payment #4 to CMSE Inc. in the amount of \$14,813.00 for payment by Delaware County OHCD. Mrs. Kerns seconded the motion. President Peterson asked if there were any questions. Hearing none, Council unanimously voted Aye on the motion, no Nays. Motion carries.

A-2 2022 DCNR C2P2 Grant – Approve Engineer to Prepare Plans and Cost Estimate for Grant Application to Replace the Existing Pavilion/Snack Bar at Bristol Lord Field.

Mr. Archdeacon stated that DCNR is offering an additional round of grants for small communities and applications are due by October 27, 2022. A 20% match is required with no cap on the project size for projects related to Parks, Recreation and Conservation.

Ms. Crawford made a motion to approve the Engineer to prepare plans and cost estimate for grant application to replace or renovate the existing Pavilion/Snack Bar at Bristol Lord Field. Mrs. Kerns seconded the motion. President Peterson asked if there were any questions. Hearing none, Council unanimously voted Aye on the motion, no Nays. Motion carries.

Mr.Archdeacon informed Council that the Street Name signs have been delivered. He had a preconstruction meeting on September 12, 2022 with the contractor. Work is expected to begin in the next two weeks or so.

President Peterson asked where the contractor will be starting. Mr. Archdeacon said he did not, however, the contractor will provide him with a schedule.
