A-2 Presentation by Agronomed Biologics – Senator Bell's Property

President Peterson offered the podium to Mr. Jon Cohn, Chief Executive Officer of Agronomed Pharmaceuticals; researcher and provider of targeted cannabis and plant-based therapy company.

Mr. Cohn offered an in depth explanation of his use of Senator Bell's Property if it should be approved by Planning and Zoning Boards of Upland Borough. A packet of information was presented to Council for their review and there were some questions for Mr. Cohn. Informational packet is included.

24. Floor Open to Public

Mrs. Stafford, Willow Way resident, approached Council. Her chief concern was to have police drive-by at the playground near Kent Park. She has experienced teenagers using explicit language; throwing trash and jumping the fence. Mrs. Stafford mentioned she called Borough Hall and spoke to Shannon to complain yesterday. She told the teenagers that she would call the police. Mrs. Stafford requested police presence to patrol the playground at dusk as she does not want to be cussed out; only so much she will take. President Peterson advised her to call 911. Mrs. Strafford said that is what the sign states, no one in the park after dusk.

Chief Irey approached Council to acknowledge the amount of citations that Lieutenant Curran and himself has assisted to write for Borough Code Enforcement Officer Kirby with various violations in the Borough. Violations include high grass and disorderly properties. There are some increased concerns in the lower portion of the borough; and to date, they have written nine (9) citations.

Chief Irey stated the some fireworks issues have subsided. His department, Lt. Curran and himself are currently reviewing their use of force policy. Chief Irey thanked Council for their time.
