Items to sell include lawn mowers & the ATV as well as other items. Mr. Ciach also stated that he received good pricing of the surveillance cameras, well below what was budgeted for this year. President Peterson asked about the question of ownership; PennDOT for the storm water drains on Upland Avenue. Mr. Archdeacon stated that PennDOT gave the storm sewer systems back to the municipalities and the municipalities will now maintain it. Mr. Archdeacon is unsure of the date of this agreement. He continued; this type of system is a storm sewer under-drain and it is under the road which is a structural part of the road and these drains are normally still maintained by PennDOT.

President Peterson stated correct; PennDOT needs to be made aware that we (Upland) have been working on this for ten (10) years and this is totally unacceptable. President Peterson mentioned she understands that while some people are not in the office (due to pandemic), but we cannot even get an answer in a month's time; it's crazy. Especially ten (10) years! What's it going to take, someone sink into a hole, who's going to be responsible for that? Mr. Archdeacon stated he will make contact again to a gentleman he's been working with at PennDOT.

Mr. Archdeacon stated the application will be made for Liquid Fuels. Mr. Ciach mentioned that according to his calculation, Liquid Fuels fund will be approximately \$ 304,000 and they can use that fund to improve the streets as well as signs. He will be working on this project with Mr. Steigerwalt.

21. Future Projects – Matthew Steigerwalt

Mr. Steigerwalt stated the most recent suggestion is to enrich the currently vacant land owned by the Borough and convert them into Community Gardens. While this idea is in the early stages, it was mentioned that perhaps the compost project could be implemented into the Community Garden project.
