Mr. Richardson What was the amount? Four hundred and some thousand dollars?

Ms. Crawford No, and I don't recall the amount.

Mr. Grillone Somewhere in the vicinity of Three hundred and thirty thousand dollars.

Ms. Crawford Yes, it was about Three, thirty. Mr. Richardson What account did that go into?

Ms. Crawford that went into a Special Revenue Account.

Mr. Richardson Okay. And is the Borough still fighting the hospital to get taxes from the 2015 –

2016 fiscal year?

Ms. Crawford Are you talking about June of 2016 to the end of the year?

Mr. Richardson Yes

Ms. Crawford I don't know if that was determined or not. I thought it was with legal. President Peterson It is with legal, the larger amount. We did not decide to go after the smaller

amounts. We didn't think they would be a fight.

Ms. Crawford

Mr. Richardson

There are several properties. We are going after, with legal, with the most value.

I have asked this before; is it possible to have the Borough bills for the Terrace
Auburn Village and the Borough, and General Fund and the Income Statements out

here on the table so we also have an opportunity to look at the bills?

President Peterson So, you want us to put something out that hasn't been approved yet? Many

municipalities, Mr. Richardson, do not do that. You're aware of that. When you

were on Council did they do it?

Mr. Richardson I'm requesting it now. I'll tell you the reason why. When the Fire Chief sues the

member and the Police Chief. Now, is any of the money being used to defend the

Police Chief and Mr. Mitchell?

President Peterson That has not even gone to the insurance carrier yet, because we just got that,

correct?

Mr. Grillone It will go to the carrier.

It will affect the insurance rate. Mr. Richardson

Mr. Richardson about the newspaper articles; Regarding the Turmoil in the Borough, from the

> Inquirer. The next one; Dual Jobs in Upland Borough. Now, from reading this article, did the borough hire this management team? Did the Borough Council

employ this management team? Yes or no?

No response from Council.

Mr. Richardson Now, let me go into this. I was told Mr. Mitchell and Mrs. Peterson; you went to

> Harrisburg to lobby for the Borough change of the Borough Code. Up to year 2010, the Borough Code stated you had to have 3,000 residents, you were not allowed to be employed up to 3, 00 (residents)? Did you, Mr. Mitchell lobby?

I did not lobby, no. President Peterson

May I speak? Mayor Ciach

President Peterson Sure. Mayor Ciach No.

Mr. Richardson Mr. Mitchell didn't go?

Mayor Ciach We were in a conference that week, I took a trip to Harrisburg to see Senator

Pileggi.

In regards to this. Mr. Richardson

Mayor Ciach Yes; Mr. Mitchell did take the trip but he did not get in to see Senator Pileggi, I did.

Mr. Richardson But both of you took the trip?

Mayor Ciach Yes.

Mr. Richardson On borough expense?

Mayor Ciach No.

None of that was charged to the Borough? Mr. Richardson Mayor Ciach No, I took that on my own personal time.

Mr. Richardson Now, do you have the "Report" available?

Yes we do, and it is a structural report, it also has personnel information on there. President Peterson

> And that report should not have been released. Or, let me ask you this question. Which report do you want? The July Final Report or the August Final Report?

Mr. Richardson the report done by the woman from management resource center.

President Peterson Once again, which report? The July Final Report or the August Final Report? They

are personnel matters. They should not have been released.

If you leave out that regarding personnel, what did it pertain? Mr. Richardson

President Peterson Basically structural information; organizational, stuff for the Police Department.

Mayor Ciach Since I am the Administrative Head to the Police Department, the first time I

officially show that report, it was at the end of last fiscal year. This fiscal year, after when Mr. Mitchell was no longer President, he submitted a letter along with the report, claiming responsibility for that report. However, he gave it to all

members of Council. I got a copy as well. However, that is an internal report; we do not release that information...I don't know how it was released. All these folks here, we don't know how it was released. And to my knowledge, the one that was

given to this Board, was dated August.

President Peterson And can I tell you that a Right-To-Know was denied. And someone, as there are

only very few people that have that report, released it.

Mr. Richardson

President Peterson

Ok. Who paid for it? Did this guy do it for nothing?

No

Mr. Richardson Who authorized this payment? Does Council with a vote? Did someone make a

motion that we hire this company? That is why I am asking? I know you guys are

a lot smarter than this.

President Peterson You know, Mr. Richardson, I'm trying to do everything. I am trying to be

transparent. I am trying to do everything the right way. I spend a lot of time going back, doing a lot of things that were done incorrectly...Please, to patronize, it's not

right. If you have a question, ask your question; and if I can answer it, I will.

Mr. Richardson

Ok, I am asking a question. Was this bill paid? And who authorized it?

Mayor Ciach Madame President, may I? I just checked with the Solicitor just so I can say this.

After I received a copy of that, I went back through the minutes of all last year; all minutes from January through December 2015. It was never approved at Council here; publicly. It was never brought up at Council here, publicly. And checks were

issued by the Borough; three (3) checks were issued to pay for that.

Mr. Richardson Mayor Ciach Would show that on the Borough monthly bills? I did not check them. Yes, I believe they would.

President Peterson

It has too.

Mr. Richardson

Okay, my next one. And I do not believe you being accused of being bias. I disagree with that. Is the borough paying for any legal services for the EEOC with everything going on? Or have they cleared the Borough?

President Peterson

Peterson It's ongoing.

Mr. Richardson

But no expenses for the Borough? Okay, but I don't think you are capable of doing

that.

President Peterson

Thank you. And it was also told to the reporter that I was not capable of doing that. But because I chose not to put my source out there. It was said in the newspaper that a source told them that I was incapable of doing it. But there certainly wasn't a source, that was put in the paper, that said that I was capable. So if we are actually out for the truth, and we are actually out for balance, and if we're actually out for fair, then I do believe that both sides of the story should go out when you are reporting something. Just like, let's go back to my job, I hold two (2). First of all, I was never just a Council person. I was also the Vice-President since day one. The Police Department did not have a secretary. I worked in there for six (6) months for free. After that, I became part time; which I still worked full time, 40 hours a week for this borough for free. So, when the job was available, yes, I took the job. I have always, from day one, abstained from Police issues.

Mr. Richardson

That's not why I'm commenting. (inaudible)

President Peterson Because of the position I hold, I work harder, then any other person that would go

into that position. Because I don't want to hear a bunch of stuff. I do my job. It's getting old. I am getting tired of getting attacked every week. I'm tired of it. I am tired of the unfairness, I'm tired of the things being reported that are a bunch of lies so that someone can sue this Borough and get money out of us for nothing.

Because two (2) people decided that they were going to just destroy things.

It's bullshit, and I've had it.

Mr. Richardson

If you recall, I said...

President Peterson

It has nothing much to do with him.

Mr. Richardson

I say this as I said this to you before, I do not believe you are capable of doing that.

President Peterson I'm not. Thank you.

Mr. Richardson Was Borough Council aware of the vehicle put on Borough property?

President Peterson Yes we were. It was put there two (2) years ago. Who knew? I'll tell you another

thing. Everybody and the milk man, has fobs to this joint. Because they can come and go whenever they feel like it. Fobs - you can open any gate or any door. We

need to get this security back under control.

Mr. Richardson I don't.

President Peterson You must be the only one; because there are plenty of people not even from this

town that have one.

Mr. Richardson explained that he only requests to have a right to a copy of the minutes and the bills every month at Council instead of doing a Right-To-Know request to get the bills for approval.

President Peterson You don't need a Right-To-Know. You can have the copies as soon as we approve

them.

Mr. Richardson Thank you.

Ms. Crawford You can get them right from the manager.

Mr. Richardson Thank you.

President Peterson As soon as all of council approves them, you can have them.

Mr. Richardson That will give me a chance to look them over. So right here, are we responsible for

this vehicle.

President Peterson No we're not. It is not ours. They were told to come and get it.

Mr. Richardson So, you are all going to the Pennsylvania State Association of boroughs. It is paid

by taxpayers fund. Is it possible for when you get back, that you could give the

resident a report that was accomplished?

President Peterson Sure, we have actually done that. When we go, we attend the classes.

Mr. Richardson asked about the Hill Street property and the cost to the borough. President Peterson explained the condemnation process and we have to do fair market value; "at this point, I believe they want more than fair market value." Mr. Richardson asked if someone could try to sell the house while it is being condemned? (inaudible response).

Mr. Richardson asked about the Code Enforcement. There is a property on Hill Street and a person jumps the sidewalk and parks on the side of the house, as there is no driveway. Mr. Richardson asked who would code Enforcement go after in this case of illegal parking? President Peterson replied "the homeowner". President Peterson asked "Mr. Grillone could you please get Mr. Kirby on that, if he hasn't done so already." Further discussion on this situation; parking on unpaved areas. Mr. Hunter stated he had problems about this before. President Peterson stated that if someone parks in front of the driveway, they are on the street and the Police can handle it. If it's in the yard or they are parking on non-pavement, that is Code Enforcement. Mr. Richardson stated we must be careful of the term of "uphold the Borough Code", and the ordinances are part of the Borough code; if the Police see something, they should have enough courtesy and go and tell Mr. Kirby. Mr. Richardson stated that Mr. Kirby as a part time worker, does a good job and he gets around. President Peterson suggested Mayor Ciach talk to the Police about this. Mayor Ciach replied he would.

Kathy Zeola, Main Street resident, approached Council. Upon approaching the podium, Ms. Zeola stated she was in support of Christine (President Peterson). "If I parked in my yard, it is legal?" The response was no. You cannot park on an unpaved area. Mr. Hunter explained about the U&O process and all were in agreement the need to use a paved driveway.

Ms. Zeola asked about the inspection of #5 Main Street. Mr. Grillone replied that an extension was granted and the extension was granted for 6 months. Ms. Zeola stated the property owner of #5 Main Street posted on a social website that she had someone working on her electricity. Ms. Zeola asked if the property owner got a permit for that? Does she need permits to get work done? Mr. Grillone replied she does need permits. Ms. Zeola asked if property owner got a permit for that. Mr. Grillone replied he did not know that for a fact, he would have to check. But she was made aware of the fact that she would need to get permits for any of the work that had to be done. Ms. Zeola stated that her main concern was her house. Ms. Zeola explained about a discussion she had with BCO Ferguson; Mr. Ferguson stated that Ms. Zeola's house was stable. Mr. Grillone stated that Ms. Zeola's house had no structural problem. Ms. Zeola wanted that statement on record as she does not agree with that statement.

Ms. Zeola further asked about the enforcement department as well as the inspector's positions. President Peterson explained the inspector's roles as well as Code Enforcement. Ms. Zeola wanted to know how the individuals got into office. Mr. Grillone explained that Council appoints the individuals to their respective positions. Also, the Building Code Official is appointed by council and that it is required he is certified by Pennsylvania and he has to take certain amount of continuing education every year to maintain his certification. Ms. Zeola wanted to know who would take care of the issue of her actually having electrical work done? The Electrical Inspector under the auspices of the Building Code Official. Ms. Zeola wanted to make sure someone make the Inspector aware of the electrical work that was done. Mr. Grillone stated he would do that.

Ms. Zeola asked if property owner fails her inspection in 6 months, will she get another extension. Mr. Grillone stated it depends on what they find and to what extent she has made the necessary repairs. Mr. Grillone stated if progress was made, that any reasonable person would give her the opportunity to complete. Mr. Grillone stated "but that is just my gut feeling. You can't predict." Ms. Zeola wanted to know how she would find out if property owner received any permits. Mr. Grillone stated "You can come into the office and check." Ms. Zeola stated "Okay. Thank you."

25. Adjournment

Mr. McClintock made a motion to adjourn. Mr. Hunter seconded the motion. Verbally, all Council voted Aye. No one opposed. Motion carries.

The meeting adjourned at 7:55 p.m.
