#### 24. Floor Open to Public

Jennifer Walls, Second Street resident, approached Council. Ms. Walls addressed Council regarding her recent post on social media. There is speeding down Front Street, where she lives and where her children, as well as other children, play. Ms. Walls offered must discussion on speeding; statistics she found on the internet about required time to fully stop when someone is driving at a certain rate of speed.

President Peterson explained that Main Street and Upland Avenue are state roads; they are governed by the State. Front Street is governed by Upland. President Peterson requested Chief Irey, Upland Police Department, to approach Council as well. To clarify, President Peterson asked Ms. Walls who she spoke to at Upland Borough about her previous complaint on this issue. Mrs. Walls did not reply. Chief Irey mentioned he scanned his voice mails, texts and emails both work and personal, and did not find any reference to a complaint from Ms. Walls.

There were suggestions to place speed bumps, conduct a speed study and/or call the Police if there are speeders in the area. Through much discussion between Ms. Walls, President Peterson and Chief Irey, it was determined that Chief Irey will visit with Ms. Walls to address her concerns about children playing and the speeding of vehicles on Second Street; hopefully to come to some type of solution to this ongoing issue.

Other comments were made regarding Second Street; children playing and property maintenance.

Rosemary Richardson, Third Street resident, approached Council. Mrs. Richardson wanted to add to the previous comments, agreeing with Mr. Hunter, that a little boy is riding a motorized vehicle onto Third Street, unsupervised, dashing between cars haphazardly and it is occurring late in the evening. These children should be supervised. Mrs. Richardson also stated that not only would she like to see the police stop speeding vehicles, but also stop the unsupervised child from riding the motorized car. Mrs. Richardson suggested that the Church Parking Lot is a safer place for the children to ride their bikes or motorized cars.

#### 25. Adjournment

Mr. McClintock made a motion to adjourn. Ms. Crawford seconded the motion. Verbally, all Council voted Aye. Motion carries.
