Ms. Crawford reported the website for November 2017 had 3,239 page views with an average of 108 per day with 1,319 visitors, with an average of 44 per day. For December 2017, the website had 4,122 page views with an average of 133 per day; there were 1,315 visitors with an average of 42 per day. Most recent photos added were for the Tree Lighting Ceremony with the Visit with Santa, the Senior Citizen's

Christmas Luncheon and the visit by Santa and the Upland Fire Company through the Borough on the fire trucks.

15. Streets & Equipment – Judith Bush

Mrs. Bush wanted to mention that the Highway Department and Maintenance men did a great job clearing the streets of the borough during the most recent wave of inclement weather. Mrs. Bush stated that not only did the residents appreciate it, but those traveling through the Borough, appreciated it.

16. Community Affairs – Moira Crawford

Ms. Crawford reported the next Community Affairs event will be the Soup and Salad Dinner on Saturday, February 17th from 4:00 p.m. to 6:00 p.m. This is a paying event; an all-you-can-eat; one of the few events that are offered by the Community Affairs Committee that help fund the other free events held throughout the year. The cost is \$ 10 for adults, \$ 7 Senior Citizens and \$ 5 for child under 12. Tickets are available in the Borough Offices.

The Sesquicentennial of Upland Borough will be celebrated in May 2019. It is the 150th anniversary of the 1869 incorporation of the Borough. There is a logo contest which began in January 2018 and will complete at the end of March 2018. All entries must include a signed waiver so the Borough can use the graphic for their unlimited use. There will be a \$ 250.00 to the winner of the logo contest.

President Peterson provided update on the Hometown Heroes Flags. The cut off for submission of names for the project will be March 1, 2018. The cost of the flag to the resident will be \$50 per flag. The Borough will pay the remainder. A scanned picture needs to be emailed to the Borough or dropped off so the office can scan the photo. This information will be published in the next newsletter.
