A-1 Recommendation for Demolition of 227 8th Street

Mr. Archdeacon stated Catania Engineering recommends A.J. Jurich to be awarded the contract for the demolition of 227 8th Street.

Ms. Crawford made a motion to award the demolition of 227 8th street to A.J. Jurich for \$49,000.00 plus Alternate #1 if needed. Mr. McClintock seconded the motion. A-2 Motion to Authorize Engineer to Advertise for Bids of the 2016 CDBG Road Program

Ms. Crawford made a motion to authorize the Engineer to advertise for bids for the 2016 CDBG Road Program. Mr. McClintock wanted to clarify where the advertisement would be published. Mr. Grillone stated he spoke to the Engineer, and there was a correction as the advertisement will be placed in the Daily Times. Mr. Dennon seconded the motion. Roll call was taken: Mr. Dennon – Aye; Mr. McClintock – Aye; Mr. Hunter – Aye; Mrs. Bush – Aye; Ms. Crawford – Aye; Mrs. Peterson – Aye. Motion carries.

President Peterson discussed the advertising in the Spirit. President Peterson stated that Mr. Hunter addressed this concern in the past. Mr. Hunter stated his issue is that a lot of people buy the Daily Times. He stated he addressed this before as he thought we should advertise again in the Daily Times. Also, he stated there are a couple of residents that buy the Daily Times and some residents were not aware of what

was going on in the Borough as they did not get the Spirit. Mr. Hunter stated he does not think we should use the Spirit to advertise our business.

Mayor Ciach had asked what the difference in pricing was. Mr. Grillone stated there was a cost difference but the Spirit is only published weekly. It added some more challenges in terms of the bidding requirements and getting bids scheduled. Although it does meet the definition of a general circulation publication; the Spirit does meet that but handicaps you. Mr. Grillone also concurred with Mr. Hunter; not many residents see it.

22. Old Business

President Peterson discussed Council and employee cell phones. Due to how the Right-To-Know laws are now, all Council members should have Borough-issued cell phones to have access to Council business and Council email. Their own personal equipment should not be used.

President Peterson stated she did an analysis of the phone bill and there were 8 to 10 phones that were not being used or sitting somewhere and still on. They have since been shut down. Also, as for the employees, per the last administration, employees were allowed to use the cell phones for both personal business and Borough business. President Peterson has since shut that down.

President Peterson stated the employees will be moved to flip phones; where they can basically conduct only business calls. President Peterson entertained a motion to change the phones. Mr. McClintock stated "So moved," and Mr. Dennon seconded the motion. Roll call was taken: Mr. Dennon – Aye; Mr. McClintock – Aye; Mr. Hunter – Aye; Mrs. Bush – Aye; Ms. Crawford – Aye; Mrs. Peterson – Aye. Motion carries.

Mr. McClintock read a draft of a letter that was presented to Council by legal counsel. Mr. McClintock read a letter:

"Upland Borough Council Members, Mayor Call for Immediate Resignation of Councilmember Ed Mitchell

"Mitchell was charged by District Attorney Whelan for theft and illegal wiretaps as part of a \$133,000 kickback scheme that involved Borough funds

UPLAND, PA – Upland Borough Council President Christine Peterson, Vice President Moira Crawford, council members Leland Hunter, Richard McClintock, Judith Bush, and William Dennon, and Upland Mayor Michael Ciach joined together today in calling for the immediate resignation of council member Ed Mitchell.

Mitchell was charged recently by Delaware County District Attorney Jack Whelan with 41 felony counts including theft, receiving stolen property, conspiracy, and illegal wiretaps, as part of an alleged \$133,000 kickback scheme. Those criminal charges were followed by a federal civil rights complaint filed against Mitchell by the Borough's fire chief, Dan Smith, who also served as a member of Borough council.

"We are appalled and strongly condemn the alleged activities and behavior of Councilman Ed Mitchell," said Christine Peterson, President of Borough Council. "For the good of the Borough and local residents, we call upon Mitchell to do the right thing and immediately resign his position on Borough Council." "Serving the community as an elected official is a privilege that I and the other board members take very seriously," said Peterson. "It is a responsibility that we are proud to do with honesty and integrity and each of us are disgusted by the alleged malfeasance of Mr. Mitchell."

"While we all understand that the law presumes that Mr. Mitchell is 'innocent until proven guilty,' in light of the severity of the pending charges, together with the duty to always uphold the public trust, we all call for the immediate and unconditional resignation of Mr. Mitchell from his position as a councilman in the Borough of Upland. We believe that by retaining that office, Mr. Mitchell brings disrepute upon the Borough.""

President Peterson asked "Do I hear that in the form of a motion?" Mr. McClintock made a motion to enter the request of resignation into record. Mrs. Bush seconded the motion. Roll call was taken: Mr. Dennon – Aye; Mr. McClintock – Aye; Mr. Hunter – Aye; Mrs. Bush – Aye; Ms. Crawford – Aye; Mrs. Peterson – Aye. Motion carries.

- 23. New Business
 - A-1 Motion to Accept Resignation of Flood Plain Administrator
 - Discussion on Replacement

Ms. Crawford made a motion to accept the resignation of the Flood Plain Administrator with regret. Mr. McClintock seconded the motion. Roll call was taken: Mr. Dennon – Aye; Mr. McClintock – Aye; Mr. Hunter – Aye; Mrs. Bush – Aye; Ms. Crawford – Aye; Mrs. Peterson – Aye. Motion carries.

President Peterson stated that discussion on the replacement Flood Plain Administrator will be address at the next meeting as they will be gathering additional information.

A-2 Update on Work and the Road Repairs at Main Street & Oak Lane

Mr. Dennon stated that Mr. Grillone's first letter to Chester Water Authority initiated the ball to repair the roadway on Main Street, near Oak Lane. Both Mr. Dennon and Mr. Grillone established a good open communication to get this job done. Mr. Dennon stated his most recent communication was with Ms. Aileen Gallagher from PECO. Ms. Gallagher updated Mr. Dennon that Kehoe Construction will be doing the remainder of the work in that area; the total restoration of replacing the sidewalks, up to Upland's standards as well as anything that was damaged in the process of their original repair.

Mr. Dennon stated permits will be need to be issued and with the collaboration of Code Department, the office, the Engineer and all involved, they will make sure the repairs are done correctly.

25. Adjournment

Ms. Crawford made a motion to adjourn. Mr. McClintock seconded the motion. Verbally, all Council voted Aye; no one opposed. Motion carries.
