Dan Smith, property owner of Patton Avenue residence, approached Council. He stated there was an ongoing issue with a sinkhole near the fire hydrant in front of his rented property on Patton Avenue. Chester Water Authority states it is not their problem, and Delcora states it's not their problem. Mr. Smith stated he has conferred with Borough Manager trying to find a solution to this problematic situation. Borough Manager Ciach asked if the engineer can evaluate this situation as it is an ongoing issue. Mr. Archdeacon from Catania Engineering stated he will contact Delcora.

Lou Kutlus, property owner of Front Street residence, approached Council. Mr. Kutlus is concerned about the tree on Borough property which is next to his rented property. He is afraid the tree is unstabled and worries it will fall onto his property. President Peterson stated they will take under advisement and check it out.

Bob C., Mulberry Street resident, approached Council as he wondered if the borough will be involved in the selling/purchasing of Senator Bell's property; concerned about big developers purchasing the property. President Peterson replied, stating the borough cannot afford the purchase of the desired property or probably cannot receive a grant large enough to purchase the property. President Peterson assured the resident that there may be other buyers interested in the property that would not be harmful to the Borough.
