President Peterson stated prior to voting	How did Sixth Street Parking Lot get on the Ordinance? It was discussed and that we were not going to do that.
Mr. Ciach	Whether we do all Borough parking lots or no Borough parking lots; so we can grandfather that separately, so it's on there for now.
President Peterson	We need to grandfather that parking lot then because the reason we are charging for the other parking lot that we are making, is because I wanted to make extra spots on those streets that don't have enough parking to allow someone to use that and we will need to maintain and keep up with that because we put money out for that. However, this particular parking lot has been there for years and years and years and even though we maintain it by plowing it, the Borough did not put anything out for that.
Mr. Ciach	There will be work done on it this year; painting and maintenance.
Mrs. Bush	Many residents from other streets park in the 6 <sup>th</sup> Street Lot; residents from Church Street and 5 <sup>th</sup> Street. Some residents from 6 <sup>th</sup> Street cannot even get a parking space in there. So even the new people that moved in and put a driveway in, they have 4 cars parking over there.
President Peterson	That is my suggestion; does anyone have another way?
Mrs. Bush	If the sign would say "For 6 <sup>th</sup> Street Residents Only", it would need to be for only 6 <sup>th</sup> Street residents.
President Peterson	If someone from another street wants to park there and they buy a permit, then they can park there.

Through discussion, Mr. Hunter also asked if guest's spots will be available. It was confirmed that there will be guest spaces available in the  $6^{th}$  Street Parking. Some discussion was inaudible.

**President Peterson** 

If someone was to visit someone on 6<sup>th</sup> Street and that person has a permit, they can temporarily park in the guest space in the lot. However, for the 8<sup>th</sup> Street Parking Lot, with only 7 spots, where there is plenty

	of on-street parking, there will be no guest spots
	available.
Mr. Ciach	We will paint the guest spots on 6 <sup>th</sup> Street like how
	we did the parking in Auburn Village.
Ms. Crawford	So, you don't get a permit for the guest spot?
Mr. Ciach	No, they will be temporary parking enforced.

President Peterson asked if there were any other further questions in keeping the Ordinance the way it is written. President Peterson asked if there was a second to the motion. Mrs. Bush confirmed.
