#### A-8 Clean Up Day Scheduled

Mr. Dennon announced a PA Clean-Up Day is scheduled for Sunday, April 23<sup>rd</sup> 8:30 a.m. to 2 p.m. Volunteers are needed. Delaware County Community Service and the Upland Fire Company will be helping as well. PennDot will donate the materials; trash bags, vests, gloves, etc. The purpose is to clean up the area, as best as possible.

#### 24. Floor Open to Public

Dana Dudek, Church Street resident, approached council. Ms. Dudek had a few areas of concern she wanted to address with Council.

Ms. Dudek reported that kids were playing on the street riding skateboards and scooters. The kids are out of control and they play chicken with the cars. They even cut off the cars when they are driving. It would not be fair if the motorist hits them. Ms. Dudek stated that she almost hit the same child two (2) times. Ms. Dudek mentioned about her own childhood, how the Police used to come into the schools.

President Peterson	There is an officer in the schools every week. I will pass this on.	
Ms. Dudek	What about citing the parents? Or confiscating their bikes? What else can be	
	done? I mean, it is really out of control. Last week there was a mob of kids.	
President Peterson	The only thing you can do at that time, is call the Police.	
Mrs. Bush	Do you know where the children liveto cite the parents?	
Ms. Dudek	We've tried to call the Police.	
President Peterson	We will take a look at that and get back to you, okay?	
Ms. Dudek	Okay.	
Mayor Ciach	Dana, you have my number. If you ever call the police and they do not come, call	
	me.	
Ms. Dudek	The Police could be on another call.	
Mayor Ciach	They are still required to show, though.	
Ms. Dudek	I would like to voice a very strong objection to Tom Kennedy being even considered for the Floodplain Administrator. I don't even think he should be the	
	Plumbing Inspector. The man is rude, not-knowledgeable about things that go on	
	in this borough. He has created havoc with a lot of residents. And, I strongly urge	
	Council not to consider it.	

Ms. Dudek	Sewer line inspections. Another thing, I am pleading with Council to rescind this ordinance. Who read these videos; who determines a pass or fail?
President Peterson	In the end, our Plumbing Inspector.
Ms. Dudek	There are cases, as to the explanation as to why they failed, is not true. And people
	have the videos to prove it. I tell you, this is suicide for this borough. I have had
	realtors state they do not want to deal with Upland, they will not take home listings
	in Upland. Property values are declining. The Church Street property value is now
	down to approximately \$ 70,000.00. That is an ultimate disgrace. Council has got
	to do something. People are just walking away.
President Peterson	The last time we looked at this Dana, we were basically told by Legal that we can't
	take it back because of the ones that we have already done.
Ms. Dudek	But the public was promised it was not going to pass and then it was passed behind
	everyone's back. That to me, Upland(inaudible).
President Peterson	It wasn't passed behind everyone's back. We have to remember when that was
	done, the borough was going to basically cover it. No one had to worry about it
	until the end. And no one wanted to do that.
Ms. Dudek	You've got senior citizen's here that
President Peterson	I understand.
Ms. Dudek	Property values are in the tank. Something desperately needs to be done. And one
	last questions, why can't the public see copies of bills to be paid?
Mrs. Bush and Ms. C	Trawford both said once they are approved.
President Peterson	Once they are approved, I have no problem with releasing them.

Mr. Garrity, Church Street resident, approached Council regarding the Sewer Lateral testing. Mr. Garrity read a sample agreement of a Seller's Property Disclosure Statement from the Pennsylvania Association of Realtors. According to Mr. Garrity it reads "the fact that a structural element, system or subsystem is at or beyond the end of the normal useful life of such a structural element, system, or subsystem is not by itself a material defect."

Mr. Garrity "Which mean if it is old and still functioning, it is not defective. The state does not even require the changing of the lateral line; the replacement of the lateral line. If we have a plumber that comes to our house, and there is a real estate transaction pending, and he says the line is fine, that is where it should end. The borough should be involved with the permit and making sure the plumber is licensed and qualified but as far as giving explicit power to give to him to demand the line be replaced, just because it is old, or has a bely or a few repairs in it, is an over-reach." If the issue is due because it is old, then that is a negotiating between the buyer and seller.

Mr. McClintock Could you make sure we get a copy of that?

Mr. Garrity If there is still life to the line, and the buyer agrees to accept that risk, because when you buy an older home, you assume that risk. That is why new construction costs more than new construction. The pluming inspector has the final say on whether or not a line should be replaced of not, like I said is an over-reach. What really truly troubles me, not necessarily with the current gentleman, but in the future, you have the possibility of schemes or paybacks. If this is ever taken to court, and the Borough is found to be a bit beyond their power...

Once again I ask the Council to reconsider this ordinance and repeal it. It is on private property and it should remain between buyer and seller. The extent of the Borough's problem, like I said, is to get the permit and to make sure the plumber is qualified...It is not the government's responsibility for the buyer exchange.

Mr. McClintock	If the inspection should show that the line is blocked, are you saying that the person	
	that owns that home should be paying to get it fixed?	
President Peterson	That doesn't have anything to do with us. That is between the buyer and seller.	

There was much discussion about the sewer lateral.

President Peterson	Mr. Garrity, we've beat this thing to death. I assure you, I promise you, that we will, as a Council, stretch out further and check this put one more time.
President Peterson	If we decide now that we are not going to do it, what about all the other people we made replace their line. And that is what I am saying to you.
Mr. Garrity	Two wrongs will not make a right.
Ms. Crawford	Ordinances can be changed; they are changed all the time. It doesn't mean that anyone is liable for anything if they change that.
President Peterson	Mr. Garrity, I just spoke to Mr. O'Connor. We will check on one more thing, I promise you we will. We will let you know by June's meeting, okay?
Mr. McClintock	I would like to have a copy of that.

With confirmation from other Council members, they would like a copy of the sample agreement of a Seller's Property Disclosure Statement from the Pennsylvania Association of Realtors.

Chief Smith When he owned a property in Upland, deciding whether to sell or not, the potential buyers that viewed his property were happy that Upland had the sewer lateral ordinance. Chief Smith stated that when he looked at potential properties in Edgemont Township and Nether Providence Township, everybody is getting the sewer lateral inspections. It is not just Upland, Delcora and the water company is also pushing for the sewer lateral inspections. Chief Smith stated he is neither for the inspection nor against it, however it is a positive thing when someone is buying the property. It is just like any other politics that goes into play, it helps some of people and it doesn't help others. And you will hear both sides of the stories; that is my side.

President Peterson Thanks, Dan.

Mr. Novak approached Council. He stated he was in agreement with Mrs. Dudek regarding the children playing. The children are unruly. Mr. Novak stated that Upland needs an ordinance about this.

President Peterson	Mr. Novak, we already have an ordinance.
Mr. Novak	You need to enforce it.
President Peterson	We do. You need to call the police.
Mr. Novak	I do call the police.
President Peterson	Okay, I will pass it on.

There was more discussion on the children playing and how they are unruly and disrespectful. President Peterson stated she will pass the information along to the Police Department.

Mr. Novak asked about the fire pit. He had a letter and gave to Mr. Ciach. President Peterson explained that two letters were needed from his neighbors, in case someone had breathing problems. Mr. Novak stated he would get them. President Peterson stated the Mr. Kirby can check it out as it is a case by case. President Peterson stated they would take care of it.

Mr. Garrity readdressed Council regarding sewer laterals and qualifications of the plumber. President Peterson ensured Mr. Garrity they will look into this situation.

Ms. Gethers, Hill Street resident, approached Council. Ms. Gethers was concerned about the park that will be coming to the area near her residence. She wanted to know if there will be trees planted along the fence. She wants to make sure that she will be able to keep her privacy. She was concerned about people walking by and her privacy. Ms. Gethers mentioned that she was concerned about the assessment of her property when the park was done. She also asked about the clock tower and how the light may reflect into her windows. President Peterson assured her that there will be no problem where it would affect her privacy. Mr. Archdeacon also mentioned that when they go to final plans, they would make sure her concerns were addressed.

Mr. Sal Deviato, Second Street resident, approached Council. He stated he also had a problem with children on the bikes. President Peterson stated that hopefully when they start the bike patrol; it will elevate some of the problems with the kids on bikes. Mr. Deviato also asked about the floodplain stick.

President Peterson asked Cindy to have Chuck look into the Children at Play signs.

## 25. Adjournment

Ms. Crawford made a motion to adjourn. Mr. Dennon seconded the motion. Verbally, all Council voted Aye. No one opposed. Motion carries.

The meeting adjourned at 7:45 p.m.
