- Spaghetti Dinner, September 14<sup>th</sup> at MacQueen Hall, 4pm-6pm; food to include meatballs, salad bar, garlic bread, desserts and beverages; BYOB event. Prices have increased this year but still lower than events similar in the area; \$12 for adults, \$10 for seniors and \$8 for children 12 and under. Tickets will be available at the Borough Office to purchase in August 2019.

President Peterson stated that the Fire Chief Dan Smith came up with a great idea; as the last couple of years we spoke about putting a water park on Second Street. President Peterson stated that idea was unfeasible as it is so close to houses.

However, they will look into working with Upland Baptist Church to possibly lease or purchase of part of the Church parking lot; this would be a central location for this water park project.

23. Old Business

President Peterson asked if Chief (Irey) had anything to say.

Chief Irey approached Council. He apologized he was unavailable to attend the last Council meeting due to a family obligation. Chief spoke about turnover in his department; recent part-time new hires and some voluntary departures.

Chief Irey updated that the online Live Scan system begins tomorrow, July 10, 2019; dramatically cutting the time the officers will spend out of town, in Chester. The Live Scan system brings a substantial amount of financing through the State for every person that is (finger) printed. Additionally, Chief Irey noted Parkside Borough, Attorney General's Office and Marcus Hook Borough have contacted Upland to possibly utilize their LiveScan System; therefore, the monies generated would stay in Upland.

Chief Irey mentioned the application for the grant from Casino funding is still pending; grants are awarded as high as \$ 50,000.00.

Chief Irey thanked everyone for their support and informed everyone that August 8, 2019 is the scheduled National Night Out event in the Bristol Lord Field.
