Mayoral Proclamation

Mayor Ciach offered his last official act as Mayor. Mayor Ciach presented Council President Christine Peterson with a Proclamation which recognized her continuous dedication to the Borough since she was elected onto Council in January 2008. At that time, Mrs. Peterson was named Vice President. She served in that capacity until December 31, 2015. On January 4, 2016, Mrs. Peterson was voted into the seat as President of Council by her colleagues. Mayor Ciach recognized Mrs. Peterson as being the first woman elected to the post of president in the history of Upland.
