The Upland Fire House will be selling refreshments in the Pavilion for individuals to purchase.

The Annual Spaghetti Dinner will be held at MacQueen Hall on Saturday, September 16, 2017. This is a paying event that helps us fund all the free events we offer. Tickets will be available in the Borough Office in August.

Mr. Yousef, a Mulberry Street resident, approached Council. He stated he is picking up trash from the ground almost every day. Also, he explained there is a lot of dog waste on the ground. Another of his concerns was that he feels there is lack of police presence in his area. President Peterson explained to Mr. Yousef that the Borough recently advertised the concerns of individuals not picking up their pets waste. She further explained that his concern regarding lack of police presence will be addressed by the Mayor with the Chief of Police. Mayor Dennon confirmed he would address this concern with the Chief of Police. Mr. McClintock stated that he is a resident of Mulberry Street and he has witnessed police

presence more so now, then he did before. Mr. Yousef replied while Mr. McClintock sees the police, he differs as he does not. President Peterson stated "Any of us can see them at anytime; no one is outside 24/7. We will make sure the Mayor addresses this with the Chief of Police." President Peterson thanked Mr. Yousef.

Mr. Oronzio, a Woodside Avenue resident, approached Council. He wanted to praise all the volunteers for the July 4th Celebration. He was in attendance and it was very nice. Mr. Oronzio asked about the Reese Center and if it is being utilized for anything at this time. President Peterson stated that right now they need to see if they can change usage' right now we have several people interested for various things. Right now it is just zoned for recreation. Mr. Oronzio asked another question; it was inaudible. President Peterson replied we would need to see if the usage can be changed and then we can determine where we go from there.
