An organization of the Borough Council of Upland was effected by a motion of Agur Castle, nominating T. B. Jarman, President, and Benjamin Crowther Secretary.

Certificate's of qualification

J. Wm Lewis presented certificate of qualification duly affirmed according to law, before Alderman Hinkson of the City of Chester S S.

T. B. Jarman, Agur Castle and Benjamin Crowther also presented their Certificate of qualification, duly sworn according to law before Joseph Holt, Alderman of the City of Chester S S.

Treasurer

On motion of J. Wm Lewis, George H. Crozer was unanimously appointed Borough Treasurer.

Tax

On motion J. Wm Lewis was appointed a Committee to wait on Lawyer Ward of Chester in reference to Road tax and Constables Bond.

Committee's

Agur Castle and John Wetherill, J. Wm Lewis and T. B. Jarman were appointed a Committee on Streets and Roads.

Benjamin Crowther appointed Committee on Health.

Instructions to Street & Road Committee

On motion of J. Wm Lewis the Street & Road Committee were instructed to say to the Township Supervisor that we want to assume the control of our proportion of the Road tax for Borough purposes, that we desire an amicable settlement of the township Road debt, and pay something for recent improvements made within the Borough limits.

Books

Mr Crowther was instructed to procure Minute and Order Books for the use of Council.

Mr Wetherill explained that he had been affirmed or sworn before Alderman Ulrich of Chester City S S. but had not his Certificate, because he told Alderman U. Mr Crowther and other members of Council would be before him for the purpose of being qualified and he thought it unnecessary to give him Certificate until the day he was sworn or affirmed, when one certificate would be made.

Special Meeting of Borough Council.

Present T. B. Jarman, J. Wm Lewis,

Minutes of last Meeting read and approved.

Report of Com. to wait on Lawyer Ward.

J. Wm Lewis reported he had consulted Lawyer Ward in reference to Road tax and Constable's Bond; his opinion was "that the Constable should report to Court and the amount of Bond would be fixed by that Body."

"The assessment of Road tax if made and signed by the proper officers, previous to our Act of incorporation, then he thought we could not assume control of it this year". He advised that we make an assessment and try to collect tax.

Report of Com. to see Supervisor's.

Mr Lewis said he had seen Mr. West, one of the Supervisor's who said the assessment was made, and that about 700 \$ would be spent on Roads within the Borough when the Stone breaking they were at work on was done and the Race Bridge repairs completed. Mr Jarman said he had seen Mr. Oake's the other Supervisor who said the tax was fixed in April.

It was moved & seconded that the report of Committee on Streets and Roads be accepted; so ordered.

Notice to Supervisor's.

On motion that the Secretary notify the Township Supervisor's to meet Council, for the purpose of coming to an amicable understanding on the subject of the division of the Road Tax.

On motion adjourned to meet on Friday evening July 9th 1869 at 8 1/2 P. M.

Upland Borough Council Chamber July 9. 1869

President, T. B. Jarman, Called the meeting to order.
Councilmen all present

On motion of Agur Castle the minutes of last meeting were not read.

President, stated the object of the meeting to be for the purpose of Confering with the Township Supervisors on the Subject of the Road tax.

Mr West was present on the part of the supervisor's but, thought he could do nothing in the absence of his Colleague Mr. Oakes.

Chairman of Council said he had talked with Mr. Oakes, who told him that they (the Supervisor's) were not willing to allow the Borough to collect Road tax, if they could legally prevent.

Mr. West in answer to the question of Mr. Lewis "when was your Assessment made?" said before the first of May 1869. Mr Lewis wished to know what amount of money they would positively spend on our Roads, if allowed to collect our tax?

Mr. West said that long ago they (the Supervisor's) had thought of spending 3/4 of our tax on our own Roads; he was then asked if they could not figure it up a little say 4/5 of

It was agreed that they should consider the matter and report some positive promise next Tuesday evening.

Special Meeting of Council. Present J. B. Jarman, J. W. Lewis, John Wetherill and B. Knauther.

Supervisors.

Minutes of meeting held July 9th read and approved. Township Supervisors West and Oakes present.

President said that the minutes just read introduced the business we had met for this evening, namely to hear from the Supervisors.

Mr West said that they had not figured up anything whatever. After a great many questions asked the Supervisors, about the ammount of repairs on Roads within the Borough limits, and several calculations of the cost of same; - together with the proportion of debt it was right for the Borough to bear - these calculations showed the tax collected in the Borough, and the cost of repairs on Roads spoken of by Supervisors; would about exhaust all the tax collected.

Resolution.

It was on motion resolved that the Borough Officers abandon all intention of taking charge of our tax and Roads for this year; or untill the second Monday in April 1870. so ordered - Supervisors retired -

Secretary stated that he was in possession of the qualification of S. A. Croser, Chief Burgess.

Imitation.

It was moved + seconded that we invite Chief Burgess to meet us at our next meeting for interchange of views on Borough improvements - adopted -

By Law, on stated meetings.

Resolved that our Stated Meetings take place on the first Tuesday evening of each Month; to meet in May, June, July and August at 8 P.M. and the balance of the year at 7 P.M. so ordered.

Special meeting of Borough Council - Present T. B. Jarman, John Wetherill, Agur Castle, J. Wm Lewis and B. Crowther. S. A. Crozer - Chief Burgess - was present by invitation.

Report - Mr Wetherill reported that Dransfield was willing to serve one year as Constable -

Matters of Police Officer and a "Lock up" were discussed and the Cellar of Reading Room viewed with an idea of making a Lock up in it -

Chief Burgess thought there would be no difficulty about it; it would be necessary to see his Brother's and obtain their consent; this he volunteered to do. The question was asked "what was the object of the petitioners for a corporate Borough here?" Chief Burgess stated the object of the Petitioners to be for the purpose of having a local government here, so that law and order might prevail in the Village.

At this point the Burgess retired.

Motion for a Lock up. Mr Wetherill moved that a lock up be made; and the Cellar of Reading Room used for that purpose providing it can be obtained from Messrs Crozer's - so ordered.

Resolution. It was on motion resolved that the President of Council be a Committee to obtain permission to use the Cellar of Reading Room for a Lock up, and to see if Chief Burgess will superintend the work - adopted -
